

## **REQUEST FOR PROPOSAL (RFP): LANDFILL GAS COLLECTION SYSTEM**

The Region 2000 Services Authority has received an unsolicited proposal under the Public-Private Education Facilities and Infrastructure Act of 2002 as amended, for a landfill gas collection system, *Unsolicited Conceptual Proposal submitted by SCS*. The Region 2000 Services Authority has evaluated the unsolicited proposal and determined it is a qualifying project according to the Act and the Authority's implementation procedures and guidelines for the Act. The Authority may also negotiate a Comprehensive Agreement with the proposer based on the proposal, and that it will accept for simultaneous consideration any competing and compliant proposals the Authority receives in accordance with these procedures within 45 calendar days, or more, of the initial posting of the notice.

The summary of the proposed Qualifying Project, is as follows:

The permitting, design, construction and operation of a full scale active landfill gas (LFG) collection and control system in Phase III at the Region 2000 Services Authority Livestock Road Landfill Facility located at 361 Livestock Road, Rustburg, VA 24588 for the purpose of recovery LFG from the Phase III waste disposal unit at the facility.

The LFG collection system shall control emissions, migration and odors in compliance with State and Federal regulations and accomplish the following objectives:

- Control malodorous emission associated with fugitive LFG to maintain good relations with the community;
- Recover LFG for beneficial use as a fuel for a future landfill gas-to-energy project;
- Control subsurface LFG migration to comply with solid waste permit requirements and provide a safe work environment; and,
- Control emissions to comply with multiple Clean Air Act regulatory program requirements (NSPS, NESHAP, GHG Mandatory Reporting Rule, etc.) threat are currently applicable, or may become applicable at some future date.

**Proposals are due 3:00 PM on March 21, 2016** at the Region 2000 Services Authority Livestock Road Facility located at 361 Livestock Road, Rustburg, VA 24588. The proposal submission requirements and format shall follow the Authority's **Implementation Procedures and Guidelines for the Public-Private Education Facilities and Infrastructure Act of 2002**, as amended which the Authority adopted on October 26, 2011. The proposal shall also include a proposal review fee of \$5000.00, payable to the Region 2000 Services Authority, at the time of proposal submission.

All proposals shall be evaluated by "competitive negotiation" of other than professional services as defined in Va. Code § 2.2-4301.

The Authority will evaluate the proposals on the basis of (i) the proposed cost, (ii) the proposed timeline for implementation; (iii) the experience and expertise of the proposers; and (iv) the specifics of the proposal in terms of efficiency and operations. The award will be made to the offeror who has submitted the best proposal on the basis of these criteria.
